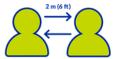

With your collaboration and dedication, I am confident we will get through the fourth wave as a stronger organization. I am grateful Horizon has such a dedicated team.

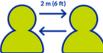
# Mandatory twice daily COVID-19 symptom screening for all admitted patients

In April 2020, the Regional Infectious Diseases Infection Prevention and Control (ID-IPC) COVID-19 Committee mandated ongoing monitoring of all admitted patients twice daily (every 12 hours) to assess changes in health status and to document accordingly in the health record using a focus note.

The symptoms for monitoring include:

- Fever/signs of fever (e.g. chills, feeling cold, shivers, etc.)
- New cough or a cough that is getting worse









- Sore throat
- Runny nose
- Diarrhea
- Headache
- Loss of taste or smell
- New onset of myalgia (muscle pain)
- New onset of fatigue
- Purple markings on fingers or toes (for children)

If a patient has been identified with at least two of the ten COVID-19 symptoms:

- Notify Infection Prevention and Control
- Collection a nasopharyngeal swab for COVID-19 (as per <u>Directive: DIR-IPC-40041)</u>

#### **Documentation:**

- Temperature will be documented on flowsheets and graphics as established in the Inpatient Nursing Practice Standards,
- Focus Charting will be done every 12 hours in the Interdisciplinary Progress Note using the focus word COVID–19 Monitoring,
  - o Example:

Focus: COVID-19 Monitoring

Response: COVID–19 Monitoring completed with no symptoms present

The focus note for patients with symptoms would include a description of presenting symptoms from screening and any actions taken.

Nurse Managers are encouraged to audit their own units regularly to ensure that any issues are resolved in a timely manner and to verify that screening is occurring every 12 hours.

# Remember to take time for yourself and access mental health supports

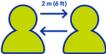
With the recent increase in confirmed COVID-19 cases, and hospital and ICU admissions, across Horizon and in New Brunswick, tensions are running high and it's important to not let anxiety get the best of us.

Horizon's <u>Employee Health and Wellness page</u> on Skyline contains many supportive resources, including information about Horizon's Employee and Family Assistance Program provider Homewood Health, which is a leader in mental health resources for employers and employees.

In addition to Homewood Health, the Government of Canada introduced a free program for all Canadians in March 2020:

• A toll-free 24/7 crisis hotline is available at 1-844-751-2133. Individuals will receive crisis counselling support and/or referral to community resources.









 A global mental health support program called <u>Wellness Together Canada</u>. It consists of free online resources, tools, apps, as well as connections to trained volunteers and qualified mental health professionals.

The increasing number of positive COVID-19 cases may be weighing heavily on your minds.

Feeling stressed and fearful every day takes a toll on our health and well-being very quickly.

As well, the <u>Canadian Mental Health Association New</u>
<u>Brunswick</u> contains multiple resources for mental well being including information about pandemic-related anxiety, and tools such as webinars, tips, and workshops.

## **GNB** update

Public Health has confirmed that two people, one in the Fredericton (Zone 3) area and the other the Edmundston area (Zone 4) have died as a result of COVID-19. There are 99 new cases of COVID-19 and 64 recoveries, bringing the number of active cases to 690.

Public Health also reported today that 80 per cent of eligible New Brunswickers are fully vaccinated against COVID-19 and 88.9 per cent have received their first dose of a vaccine.
